



EZLYNX ELECTRONIC SIGNATURE END USER LICENSE AGREEMENT

This EZLynx Electronic Signature End User License Agreement ("**Terms**") is entered into and agreed upon by you or your organization if you are using the Services on behalf of your organization ("**you**", "**your**", "**Licensee**") and Webcetera, L.P. ("**Licensor**"). These Terms apply if you are purchasing or using electronic signature (esignature) functionalities or services in connection with the EZLynx One Platform® (herein, "**Services**"). These Terms are intended to supplement any prior agreement between Licensee and Licensor, and these Terms supersede and preempt such prior terms to the extent of any conflict therewith.

BY PURCHASING OR USING THE SERVICES, YOU REPRESENT THAT YOU HAVE THE LEGAL AUTHORITY TO ENTER INTO THIS AGREEMENT ON BEHALF OF YOUR COMPANY, AND YOU ACKNOWLEDGE THAT YOU HAVE READ THESE TERMS, UNDERSTAND THEM, AND AGREE TO BE LEGALLY BOUND BY THEM. YOU FURTHER ACKNOWLEDGE THAT THESE TERMS SUPERSEDE AND PREEMPT, TO THE EXTENT OF ANY CONFLICT, ANY PRIOR AGREEMENT YOU HAVE WITH THE LICENSOR WITH RESPECT TO THE SERVICES. YOU UNDERSTAND AND ACKNOWLEDGE THAT THESE TERMS CONSTITUTE A LEGALLY BINDING CONTRACT BETWEEN YOU, AS LICENSEE, AND THE LICENSOR. IF YOU REJECT THE TERMS OF THIS AGREEMENT, YOU ARE NOT AUTHORIZED TO USE THE SERVICES. THEREFORE, YOU HEREBY AGREE AS FOLLOWS:

Licensee's Representations and Obligations

Proper Use. As a user of Licensor's services, you agree to comply with the terms and conditions of this Agreement and with all applicable local, state, national and international laws and regulations. In addition, you agree to comply with all internet regulations, policies and procedures, including all export and other laws regarding the transmission of technical data exported from any country through this Service. You agree that you will not use Licensor technology for any fraudulent or illegal purposes. You agree and understand that you may not use or distribute content that violates the privacy, intellectual property, copyright protection or other proprietary rights of any third party. You agree that you are responsible for the validity and content of all data and documents you send or process through the Licensor Service.

Fees. You agree to pay Licensor all initialization, subscription and/or transaction fees associated with the Service.

Indemnification. You agree to hold harmless and indemnify Licensor and its subsidiaries, affiliates, officers, agents, directors, managers, employees, and successors from any claims, losses, damages, suits, demands, liabilities, judgments, litigation costs and attorneys' fees arising from or in any way related to your use of the Licensor Service, your breach of any of your obligations under this Agreement, or your violation of any applicable laws or regulations.

Licensor Rights and Disclaimers

Relationship to Documents. Unless Licensor is named as a direct signatory in a document or transaction, Licensor's relationship to all documents and transactions completed using the Service by You is that of a trusted, disinterested third party. Accordingly, Licensor disclaims any representations of any kind regarding the documents or transactions that pass through the Service. You are responsible for recognizing the parties of interest in all transactions you complete using the Service and assessing all associated risks.

Limitation of Liability. YOU UNDERSTAND AND AGREE THAT LICENSOR SHALL NOT BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY DIRECT, INDIRECT, PUNITIVE, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR EXEMPLARY DAMAGES OF ANY KIND, INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFITS, GOODWILL, USE, DATA OR OTHER INTANGIBLE LOSSES (EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY THEREOF), AND INCLUDING DAMAGES RESULTING FROM: (I) ANY DOCUMENT OR TRANSACTION SENT THROUGH THE SERVICE WHERE LICENSOR IS NOT A DIRECT PARTY; (II) THE USE OR INABILITY TO USE THE SERVICE, INCLUDING



ERRORS, INTERRUPTION OR DELAYS; (III) UNAUTHORIZED ACCESS TO OR ALTERATION OF YOUR DOCUMENTS OR TRANSMISSIONS; (IV) CLAIMS MADE A SUBJECT OF A LEGAL PROCEEDING AGAINST LICENSOR MORE THAN TWO (2) YEARS AFTER ANY SUCH CAUSE OF ACTION FIRST AROSE; OR (V) ANY OTHER MATTER RELATING TO THE LICENSOR SERVICE. LICENSOR'S LIABILITY SHALL NOT EXCEED, IN THE AGGREGATE, A SUM EQUAL TO THE AMOUNT OF FEES, IF ANY, PAID FOR USING THE SERVICE UNDER THIS AGREEMENT.

YOU EXPRESSLY UNDERSTAND AND AGREE THAT:

1. YOUR USE OF THE SERVICE IS AT YOUR SOLE RISK. LICENSOR PROVIDES THIS SERVICE ON AN "AS IS" AND "AS AVAILABLE" BASIS. LICENSOR EXPRESSLY DISCLAIMS ALL WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.
2. LICENSOR DOES NOT WARRANT AND EXPRESSLY DISCLAIMS THAT (I) THE SERVICE WILL MEET YOUR REQUIREMENTS; (II) THE SERVICE WILL BE UNINTERRUPTED, RELIABLE, TIMELY, SECURE, ERROR-FREE OR FREE OF VIRUSES AND OTHER HARMFUL COMPONENTS, (III) ANY ERRORS ON THE LICENSOR WEB SITE OR SERVICE WILL BE CORRECTED; AND (IV) THAT DOCUMENTS OR MATERIALS THAT YOU STORE VIA THE SERVICE WILL REMAIN ACCESSIBLE.
3. ANY MATERIAL DOWNLOADED OR OTHERWISE OBTAINED THROUGH THE USE OF THE SERVICE IS DONE AT YOUR SOLE DISCRETION AND RISK, AND YOU WILL BE SOLELY RESPONSIBLE FOR ANY DAMAGE TO YOUR COMPUTER SYSTEM OR LOSS OF DATA THAT RESULTS FROM THE DOWNLOAD OF ANY SUCH MATERIAL.
4. NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED BY YOU FROM LICENSOR, OR THROUGH OR FROM THE LICENSOR WEBSITE OR SERVICE, SHALL CREATE ANY WARRANTY NOT EXPRESSLY STATED IN THIS AGREEMENT.
5. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES OR THE LIMITATION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. ACCORDINGLY, SOME OF THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.
6. IN THE EVENT OF ANY BREACH OF THE WARRANTIES SET FORTH ABOVE, LICENSOR'S SOLE AND EXCLUSIVE RESPONSIBILITY, AND LICENSEE'S SOLE AND EXCLUSIVE REMEDY, SHALL BE FOR LICENSOR TO CORRECT OR REPLACE, AT NO ADDITIONAL CHARGE TO LICENSEE, ANY PORTION OF THE SERVICE FOUND TO BE DEFECTIVE; PROVIDED, HOWEVER, THAT IF WITHIN A COMMERCIALLY REASONABLE PERIOD OF TIME LICENSOR NEITHER CORRECTS SUCH DEFECTS NOR REPLACES THE DEFECTIVE SERVICE, THEN CUSTOMER'S SOLE AND EXCLUSIVE REMEDY SHALL BE TO RECEIVE DIRECT DAMAGES NOT TO EXCEED A SUM EQUAL TO THE AMOUNT OF FEES PAID TO LICENSOR, IF ANY, FOR USING THE SERVICE.

Maintenance. The Service will occasionally be unavailable during system maintenance and upgrades. Licensor will make commercially reasonable efforts to ensure that the Service will be available. However, Licensor disclaims all responsibility for any interruptions or problems with the Service caused by external forces affecting the reliability of the Internet or computer systems.

Electronic Signature Disclaimer. Electronic signatures are void where prohibited by law. The United States Electronic Signatures in Global and National Commerce Act (the "Act") and the Uniform Electronic Transactions Act ("UETA"), as enacted by several states, preserve the legal effect, validity, and enforceability of signatures and contracts relating to electronic transactions and electronic signatures used in the formation of certain electronic contracts. However, as further described in the Act and in UETA, neither apply to certain contracts and records governed by statutes and regulations such as those related to probate and domestic



law matters; state commercial law; consumer law covering utility services, real property defaults and foreclosures, and insurance benefits; product recall notices; and hazardous materials papers.

LICENSOR MAKES NO REPRESENTATION OR WARRANTY REGARDING: (1) THE APPLICABILITY OF EITHER THE ACT OR UETA OR ANY EXCEPTION THERETO IN LICENSEE'S STATE OF RESIDENCE TO THE SERVICE; AND (2) WHETHER THE SERVICE COMPLIES WITH EITHER ACT. LICENSEE IS SOLELY RESPONSIBLE FOR ENSURING COMPLIANCE WITH THE ACT, UETA, AND ANY OTHER APPLICABLE LAWS OR REGULATIONS IN LICENSEE'S STATE OF RESIDENCE. General Provisions

(a) Waiver. No delay or omission by either party to these Terms to exercise any right or power arising upon the other party's nonperformance or breach will impair that right or power or be construed as a waiver of it. Any waiver must be in writing and signed by the waiving party. A waiver on one occasion will not be construed as a waiver of any subsequent event of nonperformance or breach. (b) Governing Law; Dispute Resolution. The laws of the State of Texas govern these Terms, the interpretation and construction of these Terms and all claims arising out of or pertaining to this Agreement whatsoever. The prevailing party in any lawsuit arising from or relating to these Terms is entitled to recover its costs, including reasonable attorney fees. EACH OF THE PARTIES IRREVOCABLY SUBMITS TO THE EXCLUSIVE JURISDICTION OF THE STATE COURTS OF DALLAS COUNTY, TEXAS AND THE U.S. DISTRICT COURT FOR THE NORTHERN DISTRICT OF TEXAS. EACH OF THE PARTIES HERETO AGREES TO COMMENCE ANY ACTION, SUIT OR PROCEEDING RELATING HERETO IN THE STATE COURTS OF DALLAS COUNTY, TEXAS OR THE U.S. DISTRICT COURT FOR THE NORTHERN DISTRICT OF TEXAS. (c) Injunctive Relief. Licensee hereby agrees that any breach of these Terms by it or an of its Employees making any unauthorized use of Licensor's Services or related confidential materials, will cause immediate and irreparable harm to Licensor. In the event of any such breach, Licensor shall be entitled to pursue immediate and interim injunctive relief from any court of competent jurisdiction to restrain such unauthorized use or conduct.
